
Chambers County Juvenile Drug Court



PHASES Chambers County Juvenile Drug Court

The Chambers County Juvenile Drug Court operates through successfully completing three phases. While every juvenile has an individual treatment plan that will be unique to his or her needs, the process is the same for all participants.

Phase I—three months

Program Requirement—Each treatment plan developed by the Drug Court team is individualized for the participant and family but may include the following at a minimum

Phase II—three months

Program Requirement—Each treatment plan developed by the Drug Court team is individualized for the participant and family but may include the following at a minimum. These components may be of less frequency and intensity than in Phase I

Phase III—three months

Program Requirement—Each treatment plan developed by the Drug Court team is individualized for the participant and family but may include the following at a

minimum. The requirements for this phase will be of less intensity and frequency than Phase II except for drug screen requirements.
